COVID-19 Vaccine Clinic at ESC Region 11

Which Vaccine is Being Provided?

This clinic will be administering the Pfizer vaccine, which requires two doses.

Vaccination Dates

This clinic will be administering the Pfizer Vaccine at the ESC Region 11 site on the following dates:

Saturday, March 27 (for Dose #1)

and

Saturday, April 17 (for Dose #2)

At this time, no other dates have been set to provide the vaccine at this location.

Who Is Eligible to Get Vaccinated at This Location?

This vaccination site has been designated for education employees who work in a Region 11 LEA only. Education employees must bring a district ID (badge) and a state-issued ID card (such as driver's license).

Do I Have to Work in the Region 11 Area?

Yes. This vaccination site is designated for employees who work in a Region 11 LEA only.

Registration Is Required

Do I Need to Bring Anything to My Appointment?

Yes. Registrants are required to bring the following documentation:

- **Proof of Eligibility** Education employees must bring a district ID (such as a badge) and a state-issued ID card (such as driver's license).
- Insurance Card Registrants should bring their medical insurance cards or, if Medicare Part B, the red/white/blue card. (If uninsured, please indicate this when you arrive for your appointment.)
- *Immunization Consent Form* Complete the attached form and answer the COVID vaccine screening questions front and back.

In addition, registrants should print and review the attached V-Safe Information Sheet (vaccine safety health check-in tool from the CDC) and the Pfizer EUA Recipient Fact Sheet prior to receiving the vaccine. Copies of these sheets will be available on site, if needed.

What If All of the Appointments are Taken?

Please continue to check the registration site. As interest increases, it is possible that more appointment slots will be opened for the scheduled days.

Can I Also Register My Family Members?

We're sorry, but this clinic has been designated for education employees only.

What If I Miss My Appointment?

We do not have a make-up day scheduled for those who miss their appointments.

Will There Be Any Extra Vaccines Available for Walk-Ins?

Unfortunately, this site will be conducted on an appointment-only basis. No walk-ins will be admitted.

I Have Already Received My First Dose at Another Location. Can I Register for the Second Dose at this Clinic?

We're sorry. This clinic is for recipients who need both doses of the vaccine.

Can I Bring My Children with Me?

No. We are not authorized to allow children to attend appointments with the vaccine recipient.

How Do I Get to the ESC Region 11 Site?
